Second-Hand Smoke

Limbaugh used to joke about something that Nancy Pelosi used to say all the time. Whenever she would advocate for something onerous to all of us, she'd say that it was being done "for the children." Limbaugh used to make fun of her voice and the voices of a number of other women in Congress who'd say the same thing in defense of some onerous new regulation or law. They always trotted out the women to make this claim since the "motherly" aspects of what was being done were ostensibly more believable when being made or claimed by a mom.

Here's a good example: the SCHIP (State Children's Health Insurance Program). I'll never forget Hillary Clinton's support of the program and her suggestion for its funding: a tax on cigarettes.

But cigarettes, you see, are the enemies of the state, of our finances, of our health, of humanity itself. But we won't ban their sale because, you see, moneys raised from the sale are "for the children."

Second-hand smoke regulations are also "for the children." Grownups can change location to get away from the stuff, or can tell someone to put out their cigarette, or can make rules in their establishments, be they restaurants, bars, businesses, homes, etc.

But the children are at the mercy of the grownups who may subject them to that deadly stuff that we won't outlaw because we need the taxes it generates for healthcare "for the children." It's beautiful, isn't it?

For numerous generations, we had censorship laws governing "decency" in various media, including advertising. Remember when Joe Camel was outlawed because he ostensibly appealed to juveniles, inciting their desire to smoke?

Even more recently, flavored vaping devices were outlawed altogether in some states because kids might be attracted to buy/use them because they taste like strawberries or bubble gum instead of tobacco. Of course, this too was "for the children."

It's not just the world of smoking/vaping you know. Haven't you seen or heard how much tax money is spent on the regulation of car seats and the associated laws surrounding their use? I hear radio ads for having kids in the "right car seat," five to ten times per day! Think about what's been spent on regulators getting involved in design, in monitoring manufacturing, in ensuring the "proper" instructions and warnings on the packaging, on the human talent to produce and record the media spots, on the distribution of information to the enforcing agencies and what it costs to write, produce and distribute it all, etc, etc, etc. Grownups don't sit in car seats. It's all done "for the children."

What about childhood dosing in over-the-counter drugs and remedies? Who pays for the testing, the monitoring, the enforcement of packaging information and cautions, the enforcement of locations in drug stores? Who pays the manufacturer's costs for separate manufacturing, packaging and labeling? We do, by the way: the cost increses are caused by government regulators and then passed on to us, and it's all very heavily regulated don'tcha know! But it's all "for the children."

We could go on and on with this, but you can just look around your home or office or car or store and see myriad regulatory examples of how our government does almost all its dirty work of controlling your life and mine "for the children."

But do they really do these things <u>for</u> our children, or do they do these things <u>to</u> our children, and at times, against the parents' wishes?

As we've allowed more and more involvement of our government into the *lives* of our children, we've unconsciously ceded *control* of our children, and of our own lives.

The government diabolically offers "things to keep them safe and protected." That's the actual language of the "Text4Baby" ads that run all over the country, many times per day, encouraging pregnant mothers to sign up, free, with their baby's due dates and then receive parenting instructions, safety tips, things "to keep them safe and protected," appointment reminders – which means you're giving the government not only your child's due date, but also your child's medical appointment dates.

The program is run by The Administration for Children and Families division of HHS and is as invasive as it gets. Well-funded, too.

As an aside, their deputy secretary, in charge of much of HHS' decision making, is a man, formerly married and with children, living as a woman, having changed his name to Rachel and having been awarded an Admiralcy appointment by our current government.

Today, one can go into a public library and/or a school library and find pornography available to children, including homosexual pornography. In more recent years, one can find in those places, materials that encourage children to question whether or not their parents lied to them when they told the kids what gender they are.

Here in CT where I am, and I suspect in other states as well, schools have been empowered to provide abortions for young, teenage girls without being required to inform the parents thereof.

Someone decided which schools and libraries the stuff would go to, and got paid for it. Someone approved that.

Someone put those boxes in trucks to be shipped to those various locations and got paid for it. Someone approved that.

Someone put those books on shelves and/or distributed those curricula and got paid for it. Someone approved that.

Someone looked the other way when it got onto a library shelf or into a school classroom and got paid for it. Someone approved that.

Someone got to the Attorney General of the United States to write to school boards, instructing them to request intervention and what the intervention(s) ought to be, and got paid for it. (Didn't know that, did you?) Someone approved that.

The Attorney General followed those "approved" letters and began to order the Justice Department to begin enforcement at school board meetings and got paid for it. Someone approved that.
